2. Rezoning 22-44; FMSD (Applicant/Owner); requesting to rezone an approximately 88.13 acre parcel from LI to OI. The subject parcel is located on Gold Hill Road, Fort Mill. The property is referenced as tax map number 719-00-00-199; Council District 1 - Audette.

4. Rezoning 22-49; Pamela Pendleton (Applicant) Estate of Donald Kenneth Johnson (Owner); requesting to rezone an approximately 1.12 acre portion of a 38.14 acre parcel from AGC to RUD. The subject parcel is located on Walnut Farm Road, York. The property is referenced as tax map number 386-00-00-006; Council District 2 - Love.

Diane Dil presented the request. Matt Velkovich motioned to approve with the staff recommended condition. John Segura seconded the request that was unanimously approved.

The subject parcels are located on McKnight Road, York. The properties are referenced as tax map numbers 155-00-00-014, 155-00-00-015, and 155-00-00-023; Council District 3 - Atkins.

Diane Dil presented the request. The property list has been revised to include River Hills Golf Course. Mike Duralia motioned to approve adding River Hills Golf Course to the list, but to continue in the recommendation to exclude Pinetuck Golf Course. Antonio Mickel seconded the motion. The motion was approved by all.
